

We were especially pleased with the state budget this year, with a generous increase for Independent Living and an increase in the Alternative Housing Voucher Program (may be 100 additional vouchers).

We were disappointed that the bill to align MA AAB regulations with the ADA was not even voted on in the House and the Senate. We will continue to push that issue during the upcoming informal sessions, and into next year if needed.

MWCIL is working closely with REV UP MA to get more people with disabilities voting. Some of the articles below should convince you to vote! Register by Wednesday, August 15, to vote in the September 4 state primary.

EVV Delayed

"President Donald Trump late Monday officially signed off on H.R. 6042, a widely supported bill to delay the nationwide deadline for electronic visit verification (EVV) in Medicaid-reimbursed personal care services.

The 21st Century Cures Act, signed into law in 2016 under the Obama Administration, originally required home care providers and state agencies to begin adopting EVV systems by Jan. 1, 2019. H.R. 6042, sponsored by Rep. Brett Guthrie (R-Kentucky), pushes that deadline back to Jan. 1, 2020..."

Ohio has decided to implement EVV according to the original schedule, despite complaints.

In Massachusetts, there are conflicting opinions within the disability community as to whether and how EVV should be implemented. The biggest complaint is that it is an invasion of privacy because of the geo-tracking feature. At the same time, it's not too soon to move from paper to digital data collection.

HHS APPEALS SHOCK TREATMENT COURT DECISION

The MA Executive Office of Health and Human Services has asked Attorney General Maura Healey to file an appeal of the Probate Court's decision regarding the Judge Rotenberg Center. *Healey's office has begun the appeal process.*

After 30 years of debate and condemnation by the U.S. Department of Justice, The UN special rapporteur on torture and the FDA, the aversive therapy of electric shock treatment continues to be allowed. "In June, Judge Katherine Field of the Bristol County Probate and Family Court ruled in the center's favor. The deliberation took years, following a 44-day evidentiary hearing that ended in October of 2016."

Trump Ends Union Dues for Home Care Workers

"The Centers for Medicare & Medicaid Services (CMS) has taken action to tighten Medicaid payment rules related to independent home care providers..."

Disability Integation Act

The Disability Integration Act is federal legislation that has been proposed in both houses of Congress - [S.910](#) and [H.R.2472](#). As you get to know your candidates this fall, ask the ones running for the Senate and House of Representatives if they support the Disability Integration Act. A "what's that?" answer is a problem, however, it's a teachable moment with an opportunity for followup.

What is the DIA?

[The Center for Disability Rights](#) has an excellent description. The DIA would remove the nursing home bias that exists in today's insurance and Medicaid

benefits.

This federal law would address these problems in *every* state.

- It would require both public and private insurances that cover any kind of long term care to give equal coverage to home and community support services, so you could simply choose that option if it's what you want.
- It would require this in every state, so no matter where you live, your right to independence would be the same.
- It would, in effect, add teeth to the Supreme Court's Olmstead decision, which first set out the principle that these services aren't just benefits, they are the practical embodiment of the right to independence for people with significant disabilities.

Voting Updates

The **Registration Deadline** for voting in the September 4 primary is Wednesday, August 15. PLEASE REGISTER TODAY! *Make a plan* to vote in the primary. Your vote will make a difference.

Absentee Ballots for the September primary are now available from your town clerk.



Primary Ballot information is available from the Secretary of State website.

- Visit www.sec.state.ma.us/wheredoivotema and enter your address. (note that the street address is over 3 different fields)
- Click on "Show My Results"
- See the Election Information For page. Scroll down to see the town clerk address, as well as current elected officials.
- Under View My Ballot, click on your party affiliation to see who will be on the September 4th Primary ballot. Many candidates do not have a

- primary opponent, but may have one in November.
- Consider printing the ballot, and using the remaining weeks before the primary to get to know the candidates. Candidates with opponents are very busy meeting as many voters as they can.

November Election:

Registration deadline for the November 6 election is Wednesday, October 17. *Why wait? Register Now!*

After the primary, we should see increased opportunities for debates and events where you can get to know the candidates. We also have three ballot questions to consider in November.

The ACL's (Administration for Community Living - Independent Living is under this administration) principal deputy administrator, Mary Lazare, is alleged to have publicly stated that she favors segregation of people with disabilities. The comments were supposed to have been made at two disability conferences on the same day - The Autism Society, and The National Association of Councils on Developmental Disabilities.

She is getting significant push-back from the disability community. Living in the community is central to the Independent Living philosophy.
