We're thankful that we do not have to add the losses that Yes for Question 3 would have meant. We're also pleased that Question 2 passed. While everyone agrees that 40B isn't perfect, maybe the drama of the ballot initiative will encourage legislators to fix it. Make sure you report any voting problems to the Secretary of State. MWCIL is also interested learning about any voting problems (and good experiences!) on our facebook page.

While MWCIL does not endorse any specific candidates, we are pleased that many Massachusetts elected officials who have supported IL are returning to office. Their seniority and commitment to disability issues will be especially needed in this climate of economic problems.

First, the <a href="ADDP">ADDP</a> (Association of Developmental Providers) is participating and reporting on the Department of Developmental Services' Residential Study Group who are reviewing and analyzing current community residential services...in challenging economic times. Everyone agreed that the improvements to

the MetroWest Transportation have been very beneficial to the area. The MWRTA is administered by Ed Carr who is committed to accessible transportation. Senator Karen Spilka and the General Counsel on the Senator's staff, Mary Ann Padien are credited with crafting the legislation needed to move money from the MBTA to the MWRTA (MetroWest Regional Transport Authority) so that the whole system, and accessibility to the system, could be improved for MetroWest. Ed, Karen and Mary Anne thanked Paul Spooner for his vision and input into the process.

Dr. Bigby opened her comments by stating her commitment to Health and Human Services for people with disabilities. She then opened the floor for questions. Since Secretary Bigby



oversees MassHealth among other agencies, Jini Fairley inquired if a spousal income waiver is being considered, especially for people with disabilities who need the PCA services from MassHealth in order to live in the community. MassHealth currently has several waiver programs where the spousal income is not considered for MassHealth eligibility. Jini talked about situations where people in nursing homes cannot afford PCAs on their own, but their spouse's income puts them just over the maximum income allowed by MassHealth so they may be forced to stay in a nursing home. The really puzzling thing is that it would be cheaper for MassHealth to pay for PCAs than to pay the nursing home bills. Dr. Bigby asked questions, took notes, and made sure that she understood the issues.

Ed Carr, Executive Director of the Metrowest Regional Transit Authority inquired about collaboration with para transit services that RTAs provide and the medical transportation services that MassHealth and other health state agencies provide.

Adaptive Evaluation and Training Van

### High-Tech Adaptive Van

The MA Rehabilitation Commission (MRC) recently purchased this van and adapted it with state-of-the-art high-tech assistive technology devices using American Recovery and Reinvestment Act funding.

The specifications and production supervision were provided by the Rehab Technology Dept. of MRC. The vehicle contains multiple sets of adaptive driving controls. Specific controls can be activated and deactivated. The van will be made available to Mass Rehab consumers with significant disabilities for evaluation and training. Consumers can try out different sets of controls, and ensure that they choose the best devices. The van will also be used for training consumers while they are waiting for their own vehicle to become available.

Until now, consumers had to travel out of state for both evaluations and training.

#### Health Care Reform in Need of Active Voices

Health care reform contains provisions for individuals with disabilities, but they are not yet a reality. Regulations that can improve access to medical care and independent are not yet written, making an active voice important. Stay in touch with elected officials, and stay aware of legislative calendars.

### Social Security Funding at Risk

More advocacy is urgently needed to ensure that the Social Security Administration (SSA) is funded at a level that reduces the unacceptable number of its pending claims and hearings. Americans depending on Supplemental Security Income (SSI) for their basic income, health care costs, and family support will suffer if this issue is not addressed soon. Dozens of organizations representing stakeholders of Social Security sent a letter to leaders in the House and Senate requesting that Congress fund SSA at the recommended level of 12.379 billion for FY 2011. This level of funding has been requested by President Obama, and has been recommended by crucial appropriations committees and subcommittees. These stakeholder organizations also called for funding SSA at a higher level based on the idea that an extended Continuing Resolution could help ease the considerable backlog in disability claims, appeals and hearings, and increase assistance for SSA's field offices.

It is imperative that SSA receives funding to alleviate the increase in requests for assistance primarily due to the American economic downturn. The 25-month period ending October 2010 showed a rise in claims pending a disability medical decision by 53%. The SSA field offices are continuing to see a record number of visitors while also having to process an additional 1.2 million SSI redeterminations for FY 2011, an increase of 100% from 2008. Providing SSA with the resources it needs will allow the agency to reduce the hearings backlog and protect many individuals from undue financial stress. Permitting the SSA to fund its operations during an extended Continuing Resolution would guarantee that SSA will continue to make progress in reducing the sizable backlogs that have accumulated. NCIL urges you to call your representatives in Congress and advocate for an increased funding level for SSA to adequately address this imminent threat.
