that access, acceptance and enjoyment of life in Boston are the goals of the community.

Then, our favorite speaker, Paul Spooner, spoke about the history and significance of the Americans with Disabilities Act. Paul has been a key activist since Independent Living was a grassroots movement, and was present at the signing of the ADA. He mentioned segregation and inequality, and discrimination as important motivators for the legislation. "As an American, July 4 is our day of independence. But as an American with a disability, July 26, 1990 will always be my day of freedom". Paul went on to mention the Olmstead Act of 1999 which specifies that services need to be available in the community.

## Local Public Transportation



Three MetroWest towns recently got vans equipped with lifts for riders with disabilities from the MetroWest Regional Transit Authority. "Starting July 22, Hopkinton, Holliston and Sudbury will each get a loaned, 12-seat Ford van through the state Department of Transportation Mobility Assistance Program at no cost. Each van also includes space for two wheelchairs." Read more about this

As the baby boomers age, and more people can't drive, the need for public transportation increases. Many of our suburbs have little public transportation, and even less for people with disabilities. The MetroWest Daily News recently published an <u>article</u> describing this issue.

### **Hurricanes**

Hurricanes are a very real threat to Massachusetts residents. Most communities do not have adequate drainage for the intense rainfall, and flooding can occur. High winds can knock over trees and structures, causing a loss of power and other services. Because of this threat, MEMA (MA



Emergency Management Agency) has recently published tips for individuals who require additional assistance. <u>Download the report</u> for complete information. Here are some highlights:

- Create a Personal Support Network, or Self Help Team to help you identify and acquire resources, as well as assist you during an emergency. Include people from home, school, work, and where ever you spend significant amounts of time.
- Complete a Personal Assessment of what your capabilities and limitation, and what assistance you need.
- **Become informed** about your community's Emergency Plans, evacuation routes and shelter locations.
- Learn about your community's Alerting/Warning Systems.
- Contact your local Emergency Management Director to learn about available services.
- Develop a Disaster Supply Kit for 3-5 days. Plan a Portable Kit for evacuating.
- Make an Emergency Plan including family communications, and plans and back-up plans with your service providers.

## Super Committee Info

Along with raising the debt ceiling in August, legislators also agreed to a new Super Committee of 12 legislators. Their mission is to come up with at least \$1.2 trillion more in spending cuts, with \$1.5 trillion a more desired outcome. If they fail to propose an agreement, or if the Senate and House fail to approve their agreement, then \$1.2 trillion in cuts will be automatically allocated evenly among the Pentagon's budget and programs for the middle class. These "trigger" cuts are supposedly a big enough incentive to each party so that the committee members will compromise and work together. We'll see.

**Sept 16** - Deadline for supercommittee to hold its first meeting.

**Oct 14** - Deadline for House and Senate committees to submit recommendations to supercommittee, if they choose to do so.

**Nov 23** - Deadline for supercommittee to vote on plan with at least \$1.5 trillion in savings.

**Dec 2** - If supercommittee approves plan, deadline to submit report and legislative language to President and Congress.

**Dec. 9** - If legislation is approved by the supercommittee, each committee receiving a referral of the supercommittee bill must report that bill without amendment by this deadline.

**Dec. 23** - Deadline for House and Senate votes on supercommittee **plan**.

**Dec. 31** - Deadline for House and Senate to vote on a balanced budget amendment to the constitution (cannot vote sooner than Oct.1).

Jan 1 - If Congress has not passed a joint resolution of disapproval, Secretary of Treasury is authorized to raise the debt limit by an additional \$500 billion. Any agreed upon deficit savings from the supercommittee would be credited against the \$1.2 trillion sequestration, i.e. across the board cuts in non-exempt programs. Jan 15 - If the supercommittee's plan fails, or falls short of \$1.2

**Jan 15** - If the supercommittee's plan fails, or falls short of \$1.2 trillion in savings, sequestration would be triggered and start in 2013.

The president's third and final debt-increase is likely to come some time in early 2012.

## President Obama and the ADA

President Obama released a Proclamation on this important anniversary. ... "Despite these advancements, there is more work to be done, and my Administration remains committed to ending all forms of discrimination and upholding the rights of Americans with disabilities. The Department of Justice continues to strengthen enforcement of the ADA by ensuring that persons with disabilities have access to community-based services that allow them to lead independent lives in the communities of their choosing. Under provisions of the Affordable Care Act, insurers will no longer be able to engage in the discriminatory practice of denying coverage based on pre-existing conditions, and Americans with disabilities will have greater control over their health care choices. And last year, I signed an Executive Order establishing the Federal Government as a model employer forindividuals with disabilities, placing a special focus onrecruitment and retention of public servants with disabilities across Federal agencies."...
