## **Budget Surplus**

Governor Deval Patrick filed a supplemental budget in late August to "spend" our \$460 million surplus for the fiscal year that ended June 30. He has proposed to send \$300 million to the MA rainy day fund, \$16 million towards tornado and snow damage, \$35 million to shovel-ready projects, and about \$28 million for education and jobs. He also is directing approximately \$18 million towards human services. The full budget can be viewed at the <a href="Provider's Council website">Provider's Council website</a>. ## **Transportation Services**

**Executive Order No. 530** 



The general public is invited to six **Listening / Comment Sessions** which have been scheduled across the Commonwealth to seek input from the public. ASL, CART and Spanish language interpreters, along with listening devices, will be available. All locations are accessible to persons with disabilities and by public transit. Governor Patrick's <u>Executive Order 530</u> charges the Commission members to examine and offer suggestions to improve/reform community, social service and paratransit transportation. The Commission is asking for input on recommended reforms, restructuring and cost-savings initiatives, including:

- Recommended service improvements or modifications to maintain or enhance current service levels and delivery method while achieving efficiencies and cost-savings;
- Potential modifications, if any, to existing eligibility criteria utilized by the RIDE, Regional Transit Authorities and human service agencies
- Any other reforms, initiatives or improvements to paratransit services in the Commonwealth that will enhance the quality, customer-service or efficiency of these services.
