The Super Committee failed, and the country is now facing "sequestration", meaning automatic pruning of federal budgets, with no discussion on the individual merits or options. While social services took a smaller hit than other programs, many of our state services rely heavily on federal funding, so we definitely will notice the cuts. The Council of State Governments has written a report on what they think this will mean to states.

An important MassHealth Public Hearing is scheduled for January 4 on Dual Eligibles.

We'd like to thank everyone who celebrated the holidays with us at our annual Holiday Party. We are especially grateful to Mass. Rehabilitation Commissioner Charlie Carr for taking the time to attend and socialize with all of us. We had good food, great company, and even a magician to keep us all entertained!

Occupy Wall Street

Demonstrators continue to Occupy Wall Street and other business districts around the country. David Schultz at MinnPost.com writes extensively about the goals of the Occupy movement which highlights the growing political and economic inequalities in the U.S. The disability community feels these inequalities, with higher rates of poverty and unemployment than most other groups.

With the November 17 Day of Action, the movement appears likely to continue gaining support. People with disabilities may want to get involved, and keep the dialogue focused on inclusion.

On December 7, The EOHHS released the PROPOSAL TO THE CENTER FOR MEDICARE AND MEDICAID INNOVATION STATE DEMONSTRATION TO INTEGRATE CARE FOR DUAL ELIGIBLE INDIVIDUALS

Two Public Hearings have been scheduled - one has already occurred on December 16. These hearings will provide members of the public an opportunity to give oral comments on the draft Demonstration Proposal (see "Related Information" section on MassHealth's duals website). Commenters may also submit written testimony at the public hearings. Reasonable accommodations will be made for participants who need assistance. The second hearing is scheduled for:

January 4, 2012, 10 a.m. - 1 p.m. (Wednesday)
State Transportation Building, Conference Rooms 2 and 3
10 Park Place, Boston, MA

The issues are extremely complex and any mistakes will have huge consequences. Learn about the proposal at the state website, and find out what the leading advocacy groups (*) think. DPC-MA and Boston CIL have published a Flyer and Talking Points. They have concerns about insurance company roles, and are asking that interested people "speak on what works and what doesn't in healthcare". They have identified three key issues for people with disabilities.

Revenue assumptions are similar to 2012 Increased spending pressures from debt and pension responsibilities

Some revenue sources in 2012 were one-time investments.

After several years of reducing budgets, more cuts for 2013 will cause *reductions in services*. And Secretary Bigby expects reductions in the 2013 budget.

With over 200 people in attendance, advocates for people with disabilities gave testimony for over 2 hours - from speakers in support of Day Rehab to supporters of Independent Living, DBCAN, mental health services, options counseling, deaf services, blind services and much more:

Hang Lee of Boston's Muticultural Independent Living Center spoke up for Independent Living.

Joe Bellil, VP of Easter Seals and BOD President at MWCIL, spoke about the importance of Assistive Technology and Employment.

Paul Spooner, Executive Director at MWCIL, talked about the state independent living centers, and the important work that is done. He asked for an increase in funding, so that more work can be accomplished. 150 - 200 individuals are moved from nursing homes to the community. Each individual not in a nursing home saves the state at least \$20,000 per year.

Steve Higgins, Executive Director at IACIL also spoke of the importance of the state's independent living centers, and how level or increased funding is necessary.
