ADAPT Action in Washington D.C. April 21 - April 24

Hundreds of ADAPT activists are protesting in Washington D.C. this week. They have released a **Platform for Disability Rights Change at the White House**. First on the list is developing legislation to end Medicaid's institutional bias.

More than 3 dozen disability rights activists were arrested near the White House on Monday, April 22. 200 demonstrators with ADAPT are seeking a

Budget Amendment

Representative Ellen Story (Amherst) has filed an amendment to the budget in support of Independent Living.

Amendment #377 to H.3400 Independent Living Centers

Representatives Story of Amherst, Ayers of Quincy, Balser of Newton, Brady of Brockton, Dykema of Holliston, Farley-Bouvier of Pittsfield, Fresolo of Worcester, Garballey of Arlington, Gregoire of Marlborough, Hecht of Watertown, Heroux of Attleboro, Madden of Nantucket, O'Day of West Boylston, Sannicandro of Ashland, Scibak of South Hadley and Walsh of Framingham moves to amend the bill in section 2, in line item 4120-4000, by striking out the figures "\$13,099,883" and inserting in place thereof the figures "\$8,313,930";

and, by inserting after line item 4120-4001, the following item:- 4120-4002 For Independent Living Assistance Services \$5,885,953

National Fair Housing Month

April is National Fair Housing Month The U.S. Department of Housing and Urban Development (HUD) and the National Fair Housing Alliance (NFHA) has launched a national media campaign to educate the public about the Fair Housing Act. One print ad features a woman in a wheelchair



with a service animal, drawing attention to persons with disabilities who often

face housing discrimination.

The Fair Housing Act was passed in 1968, and makes it illegal to discriminate in the sale or rental of housing based on race, color, sex, religion, national origin, familial status or disability. Anyone who experiences discrimination should call HUD's housing discrimination hotline (1-800-669-9777), contact a local fair housing agency, or visit HUD's fair housing Web site: www.HUD.gov/fairhousing.

In addition to addressing discrimination in sales and rentals, HUD also "takes on discrimination against people with disabilities in mortgage lending".

"The Fair Housing Act prohibits lenders from requiring extra income documentation from people with disabilities when their receipt of certain benefits already demonstrates a fixed income that is likely to continue. The Fair Housing Act further prohibits lenders from inquiring about the nature or severity of a disability."

Consumers and caregivers spoke about their personal situations, and how a Salary Reserve increase would benefit everyone.
