## Upcoming Budget Vote *PCA and AFC Facing Cuts*

Governor Baker wants to balance his budget on the backs of people with disabilities and elders, including restricting eligibility for the Personal Care Attendant and Adult Foster Care programs by increasing the number of Activities of Daily Living with which one must need assistance to qualify, and *giving himself authority to alter benefits for all optional Medicaid services.*

The legislature may vote to approve the budget changes as early as this coming Wednesday, Feb. 11, so please contact legislators right away.

Contact your legislators, and the leaders listed below with the following message:

*"Don't cut Personal Care Attendant and Adult Foster Care services!  
Don't give the Governor a free hand to change Medicaid as in Section 7 of his proposed legislation."*
